REQUESTER'S EVIDENCE IN SUPPORT OF CLAIMS

Pursuant to this Court's Order dated March 18, 2025 and R.C. 2743.75€(3)(c), Requester provides the following information in support of his claims:

On twelve separate occasions between May 24, 2024 and December 20, 2025, Requester made written requests for public records to Respondent. Most of the twelve requests were not acknowledged as received until January 16, 2025. Requester sent follow up emails, and often asked for updates on when the information would be received during public comments and regularly scheduled meetings of the Respondent's Board of Trustees.

Requester met via Zoom on November 29, 2024 with Respondent's Township

Administrator Susan Bedsole to ensure that she was in receipt of each written request made that remained outstanding¹. At the time, Ms. Bedsole was burdened with significant health issues.

Additional follow up emails were sent on December 16, 2024, December 20, 2024, December 29, 2024, and January 7, 2025. On January 7, 2025, Trustee Evans responded again about seeking a legal opinion on the various requests, and ultimately berating the Requester on January 10, 2025. These exchanges are included at pages O1-10. To date, Requester has not received

any of the records requested, nor a legitimate denial nor application of proper exemption to any request.

It is Requester's desire to resolve this matter and have the records produced. Requester is willing to receive the records on a "rolling" basis so as not to overtax the Township employees.

Some of the records requested are solely in the possession of Trustee Evans and should be produced without further delay.

May 24, 2024 Request

Attached at page A1 is the May 24, 2024 request for information related to zoning violations, and discussions related to M-1 zoning. The audio recording of the Board of Zoning Appeals organizational meeting was supplied. On June 3, 2024, the acknowledged as "received and forwarded to legal counsel for review."

June 13, 2024 Request

Attached at page B1 is the June 13, 2024 request. No response has been received.

June 13, 2024 #2 Request

Attached at page C1 is the second request made on June 13, 2024 for text messages between Trustee Mark Evans, and an appointee to the BZA, Rachel Zelazny. No response has been received.

June 14, 2024 Request

Attached at page D1 is the June 14, 2024 request for communications between Trustee Mark Evans, and Zoning Commission chair, Litichia McIntyre. No response has been received.

June 30, 2024 Request

Attached at page E1 is the June 30, 2024 request for communications between the Trustees related to agenda items for meetings of the Board of Trustees. No response has been received.

August 12, 2024²

Attached at page F1 is the August 12, 2024 request for the video recording of the August 6, 2024 Board of Trustees meeting made by Trustee Evans. Trustee Evans' routinely records the

Board of Trustee meetings, and other Township public meetings by video. The August 14, 2024 response that Mr. Evans sent at page F3 was that "this is not township sanctioned nor township records. This has been done privately by myself as a resident for over 5 years." However, as pointed out by Trustee McKee on August 14, 2024, Mr. Evans has been (apparently) instructed that his recording of the public meetings while Mr. Evans is a Trustee are, in fact, public records. No video recording has been produced.

September 17, 2024-1 Request

Attached at page G1 is the September 17, 2024-1 request for audio/visual recordings of executive sessions. At the September 17, 2024 regular meeting of the Board of Trustees, Mr. Evans discussed the fact that he had been recording the executive sessions to protect his own safety. Likewise, he reported on his Trustee Facebook page that he was recording the sessions which he believed were public records. A screenshot of this declaration is attached at page Q1-2. Mr. Evans also published an email confirming the recordings, and his belief that the recordings are public records. Except to report that the Respondent was seeking a legal opinion about whether the recordings made for no other purpose than Mr. Evans' ability to protect his safety were public records, no response has been received. Mr. Evans sent an email on February 28, 2025 (page O1) addressing the request for prosecutor opinion despite his prior statements and writings that the recordings were public records. No recordings have been produced.

September 17, 2024-2 Request

Attached at page H1 is the September 17, 2024-2 request for an email from the Prosecutor's office. While it would normally be presumed to be a privileged communication, it was specifically discussed that privilege would be waived for the email at the September 17, 2024 Board of Trustees' meeting (R9).

September 18, 2024 Request

Attached at page I1 is the September 18, 2024 request. Often, when Mr. Evans posts the videos he routinely makes of Township public meetings to his Mark Evans – Etna Township Trustee Facebook page, he covers over the video with is written commentary about what is shown in the video recordings. I asked for copies of two meeting videos without Mr. Evans' commentary. No copies unedited versions of the video recordings have been produced.

October 13, 2024 Request

Attached at page J1 is the October 13, 2024 request. No response has been received.

October 19, 2024 Request

Attached at page K1 is the October 19, 2024 request. On November 4, 2024, I responded to a request for clarification related to the request (K2-3.) No further response has been received.

December 20, 2024 Request

A request was made on December 20, 2024 request for a list all public records that are pending without response as of that date. There has been no response to this request. Despite best efforts, Requester has not been able to locate this email. However, receipt of the request is acknowledged by Ms. Bedsole on behalf of Respondent at P2.

December 20, 2024 (second) Request

Attached at page M1 is the second request made on December 20, 2024. I asked for text messages between Trustee Evans, and Steve Slyh for a specific period of time. Mr. Evans uses his private cell phone for both public and private message. A number of Township related text messages have been revealed to the public, primarily by Mr. Slyh. No response to this request has been received.

December 29, 2024 Request

Attached at page N1 is the December 29, 2024 request. No acknowledgement nor response has been received.

As required by the March 18, 2025 Order, attached is a Table of Contents, and each of the requests and other related documents.






